

## 3RD INTERNATIONAL ASSAM ISLAMIC UNION CONGRESS PRESS RELEASE

DECEMBER 16, 2019

**ASSAM** Association of Justice Defenders Strategic Studies Center will hold **the third “INTERNATIONAL ASSAM ISLAMIC UNION CONGRESSES”** on **19-20, DECEMBER 2019** in “Istanbul PULLMAN Hotel”.

The **3rd International ASSAM Islamic Union Congress** will be implemented with the theme of “**ASRICA (Asia-Africa) JOINT DEFENSE INDUSTRY PRODUCTION**” under the main title of “**Determination of Principles and Procedures of Common Defense System for the Islamic Union**”.

Üsküdar University, Kütahya Dumlupınar University, the Union of Islamic World (UNIW) and Association of Justice Defenders (ASDER) will actively support the 3rd International ASSAM Islamic Union Congress, which is the ASSAM Organization.

At the 3rd International ASSAM Islamic Union Congress, which will start with the Opening Session on Thursday, 19 December 2019 at 10:00; 58 academicians from seven countries will be presented in six sessions with two halls, under the Sub-Topics of the Congress Program below. The academic study of the Congress will be completed with the final evaluation session to be held before noon on December 20, 2019, and the CONGRESS will be closed at the end of the afternoon trip to BAYKAR MAKINA facilities.

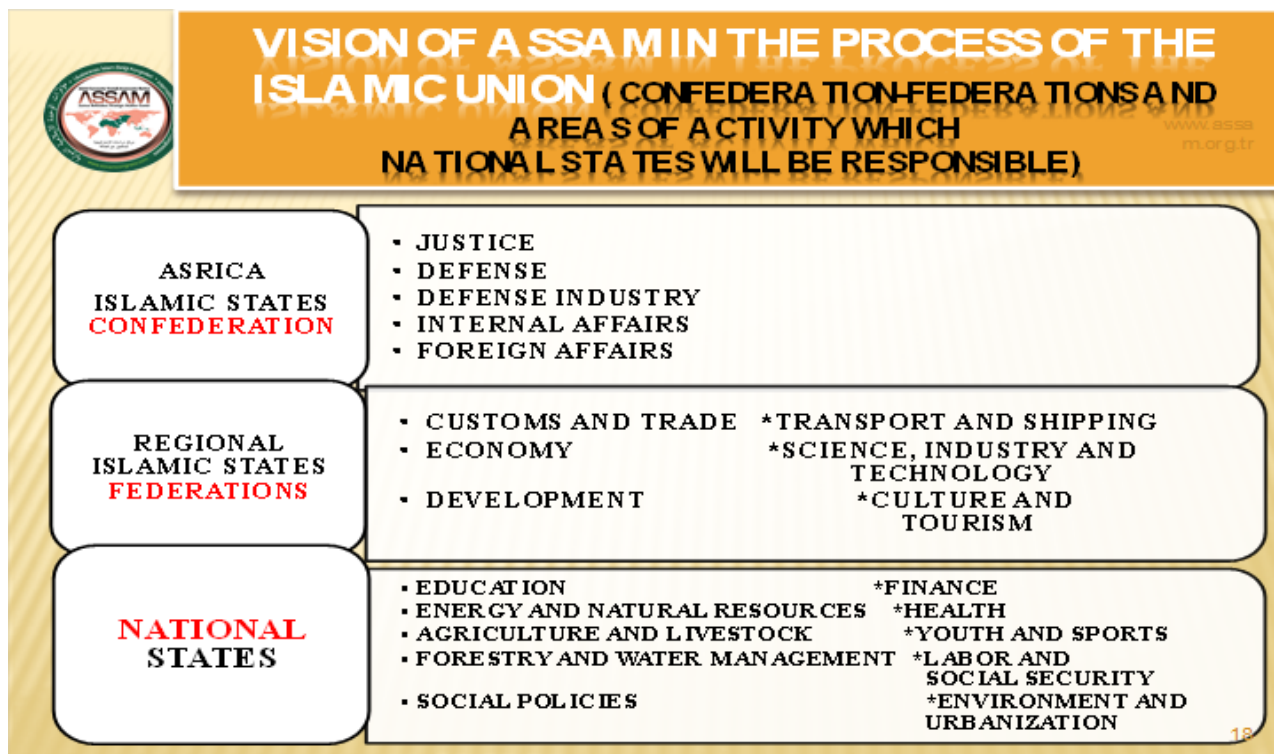

**ASSAM** is a Research Center Association that conducts intellectual studies in order to present the INSTITUTIONS that should be in order for Islamic Countries to gather under a will and the LEGISLATION that these INSTITUTIONS should comply with as a model to the rulers of the age.

**NINE REGIONAL FEDERATIONS** and a **CONFEDERAL** structure formed by these regional Islamic Federations without changing the national borders and structure of 61 Islamic Countries (27 Asia, 28 Africa, 4 Europe, 2 South America) on the ASRICA pivot, according to their ethnic and geographical proximity. It seems possible to establish the **ISLAMIC UNION** by gathering under a will.



**ASSAM** envisions that an Islamic Union can be established in such a way that the Islamic State Confederation of ASRICA is responsible for its five main fields of activity, the Regional Islamic Federations are responsible for six fields of activity, and the National States are responsible for ten fields of activity.



It is within the scope of ASSAM studies to point out the characteristics that this geography gives to people by considering the geography on which the Islamic World is based and the Asia and Africa Continents where the Islamic Countries are predominantly located and by qualifying it as ASRICA.

Of the 193 States that are members of the United Nations Organization, 61 (*31% of the number of members*) are Muslim countries.

1.85 Billion of the World Population of 7.632 billion (*24.1% of the World Population*) is the people of Muslim States, 30.9 million Km<sup>2</sup> of the world land which is 150 million Km<sup>2</sup> (*20.6% of the Lands*) are the lands of 61 Islamic Countries.

which owns 55.5% of the world's oil reserves, 65% of its production also 64.1% of natural gas reserves, 40% of its production;

In the World Defense Expenditures, which is a TRILLION 770 BILLION dollars, it is in the **THIRD** rank with 191 BILLION DOLLARS, after the USA and CHINA;

Ranks **FIRST** in number of TANK (28.760), ARMORED VEHICLE (84. 063), TOP (26. 184)

and WAR SHIPS (2.577);

THE ISLAMIC WORLD RANKS **SECOND** IN THE WORLD, after the USA, in the NUMBER OF FIGHTER AIRCRAFTS (10,986) and HELICOPTERS (3,937);

It has the potential to be the superpower of the future in ASRICA by combining its geopolitical position, common civilization values and historical background with its opportunities, efforts and goals.

Despite this Real potential of the Islamic World, it is;

- Today the most intervened in their lands,
- Most occupying the United Nations,
- Terror and anarchy are not lacking in their land,
- Resources managed by foreign powers,
- Human rights and freedoms are violated,

- **The income distribution is corrupted,**
  - **Political, social and economic instabilities prevail,**
  - **Demanding and needing the help and support of external powers to solve internal problems,**
- are the Islamic States.**

ASSAM has planned International CONGRESSES to put forward a model that will gather Islamic Countries under one will.

In the **1st International ASSAM Islamic Union Congress** held in 2017, the theme of **“ADMINISTRATION FORMS FROM THE PAST FROM THE FUTURE”** was covered in the Main Subject of **"Determination of the Legislation of the Forms and Bodies of Governance for the Islamic Union"** and at the end of the Congress;

For the welfare of the Muslim Nations, the security and survival of the states they have established, the establishment and maintenance of peace in the world, the dominance of justice and for the Islamic World to re-emerge on the stage of history as a superpower; It **DECLARED** to the Public that the **ISLAMIC COUNTRIES**, which accept the **“ASRICA”** Geography of **ASIA-AFRICA**, should be gathered under a will, and for this, the **“HOUSE OF REPRESENTATIVES OF ISLAMIC COUNTRIES”**, which will operate permanently, should be established urgently[1].

The Draft of the **CONFEDERATION OF ISLAMIC COUNTRIES CONSTITUTION**, in Turkish, Arabic and English which consists of 63 pages and 181 articles, has been placed on the ASSAM WEB Site and presented to the Global Public Opinion [2].

**In the 2nd International Islamic Union Congress held in 2018, the theme of "Islamic ECONOMY AND ECONOMIC SYSTEMS"[3] in the Main Subject of "Determination of the Principles and Procedures of Economic Cooperation for the Islamic Union" and at the end of the Congress;**

**In order for the Islamic countries to reach a level of prosperity above world standards and gain their economic independence; Using the technology of the age, encouraging production, based on the exchange of goods and services, interest-free, protecting labor-capital-consumer, providing fair income distribution, unaffected by the fraudulent manipulation of global powers, having an autonomous money circulation system, as a second step towards the Islamic Union, For this reason, it is necessary to establish the economic system;**

- Establishment of a **customs union** between Islamic countries,
- Establishment of a **common market** between Islamic countries,
- The acceptance of **monetary union** between Islamic countries,
- Establishment of **trade zones** between the members of the Union,
- To give **zakat institution** an institutional identity under the control of states as a **common fund**,
- Establishment of the **Chamber of Commerce, Commercial Courts and Foundations** affiliated to the Union,
- Formation of **the Islamic electronic dinar currency (ASRICA Dinar)**,
- Forming a **Common Market and joint production and R&D incentive fund**,
- Resource planning work with the **common investment fund**,
- Establishing a joint organization for **R&D and Innovation** activities,
- **Establishing cooperatives-cooperation systems between Islamic countries in the mining, energy, agriculture, transportation and telecommunication and food sectors of Islamic countries** and supporting **Islamic financial institutions**,
- Establishment of **ASRICA, BANK FINANCIAL TRANSFER CENTER (ASRICA-BAFAM)**,
- Taking measures **to increase foreign trade volume** among member countries,
- Establishment of **trade centers**, signing **preferential trade agreements** between Islamic countries,
  
- **Dissemination of “Barter Trade, Participation Banking, Cooperation System and Foundations”**,
- **Elimination of political obstacles, economic system differences, instability and economic problems** that hinder Economic Cooperation,
- Developing **cultural affinity between Islamic countries in the combination of language, religion and history, establishing a strong political will**,

It has been declared as required and the Declaration [4] has been made available to the World Public on the ASSAM WEB Site.
